We Need New Board Members

Have you thought about serving on the Swim Club board? Know someone who would be a great board member? It's a satisfying way to support our community, and board members have their annual dues waived. See the summary descriptions on the back.

Forest Hills Swim Club Board Positions

In addition to the responsibilities outlined for each position, board members are expected to attend quarterly board meetings and the annual membership meeting. The term is for two years, during which time annual dues are waived. Below is a summary of each position, please see our website at foresthillsswimclub.weebly.com for a more detailed description.

President (Sean resigned and was appointed treasurer for Jan.-Mar. 2018)

The President is responsible for the overall operation of the pool, including signing checks, ordering repairs and pool service, managing complaints, and scheduling/running all meetings.

Treasurer

The Treasurer is responsible for the financial transactions of the pool, including payroll, processing member dues and refunds, maintaining a balance sheet, and paying bills. In addition to the annual dues waiver, the treasurer is paid \$300 per quarter.

Lifeguard Supervisor

The Lifeguard Supervisor is responsible for ensuring the pool is staffed with reliable, qualified lifeguards. This includes recruiting new lifeguards as necessary, approving timesheets, scheduling, and communicating with lifeguards throughout the season.

Gatekeeper Supervisor

The Gatekeeper Supervisor is responsible for ensuring the pool is staffed with reliable gatekeepers. This includes recruiting new gatekeepers as necessary, approving timesheets, scheduling, checking that cleaning duties are performed and communicating with gatekeepers throughout the season.

Yard Maintenance/Supplier

The Yard Maintenance/Supplier is responsible for cutting the lawn (typically every 1 to 2 weeks) and otherwise maintaining the landscaping. This position also purchases supplies for pool maintenance as well as cleaning and paper products.
